McLean County Commission Proceedings Tuesday, September 15, 2020

The final regular September meeting of the Board of Commissioners was called to order at 8:36 a.m. by Chairperson Steve Cottingham. Present were Commissioners Cottingham, Steve Lee, and Barry Suydam. Also present were Highway Superintendent Jim Grey, Human Service Zone Director Steve Reiser, Disaster Emergency Services Manager Noelle Kroll, Auditor Beth A. Knutson, Deputy Auditor Nancy Leidholm, and Tyson Smedstad of BHG News Service.

Moved by Lee, seconded by Suydam, to approve the minutes of the previous meeting as submitted. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

Highway Superintendent Jim Grey joined the meeting. He informed the commission that the plow truck and sickle mower had arrived with plans to use the mower this weekend. Grey stated that the truck is in good shape. He reported that mowing is going on around the county and estimated that crews should finish up late October, possibly going back and redoing areas mowed early on. Gravelling is continuing. Grey then discussed pursuing gravel crushing at the Johnson pit this fall with 25,000 tons or more available. Lee questioned Knutson about funds for payment with the auditor stating that it was ok. Lee suggested that paying for the gravel this year can result in a deduction from next year's budget. Discussion followed with the commission requesting Grey to contact Sundre Sand and Gravel to see about flexible payments.

Moved by Lee, seconded by Suydam, to authorize Grey to crush and stockpile gravel from the Johnson pit. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

Disaster Emergency Services Manager Noelle Kroll was present to request the commission's approval of overtime for county employees to take part in a full-scale active shooter exercise scheduled for November 12. She estimated the exercise should wrap up about 7:30 p.m. Lee feels inclined to allow employees that take part to be able to follow through to completion. Knutson stated that it would be compensatory time and the employees would be encouraged to use it within the same month.

Moved by Suydam, seconded by Lee, to authorize compensatory time for courthouse employees to take part in the active shooter exercise scheduled for November 12, 2020. Kroll stated that a letter will be sent to department heads with information regarding the exercise along with the authorization for overtime. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

Dakota Central Human Service Zone Director Steve Reiser was present to present his 2021 budget to the board stating that salaries and benefits make up about 50% of the budget. Salaries reflect a 2.5% increase; Income Maintenance shows an increase of \$10,660.37; Travel remaining the same as 2020; Operating Expenses show a reduction of \$830.00 for 2021; and General Assistance shows a decrease of \$8,719.43. The revenue side shows a decrease in the State Payment line item of \$16,254.93 with the remaining line items remaining the same. The total department budget shows an overall decrease of \$16,254.93. This budget will be paid by the State as they are financing the costs for the department. No county dollars are being requested.

Reiser then presented his Indirect Cost budget for 2021 which shows a decrease from \$63,115.00 for 2020 to \$62,870.00 for 2021. Reiser explained that no mills will need to be levied as money will be received from the state.

Knutson presented the 2021 Police Contracts for the cities of Max and Underwood for signing.

Steve Burke and Mike Briggs of Falkirk Mining Company joined the meeting to petition the board for a hearing to mine within 100 feet of right-of-way and to temporarily close certain section line roads.

Moved by Lee, seconded by Suydam, to approve the following Notice of Hearing:

Knutson presented for signing a service recognition certificate for Lillian Boeshans who is retiring from the Dakota Central Human Service Zone.

Assistant Jail Administrator Wade Krohmer was present to request permission to order ten mattresses for the jail.

Moved by Lee, seconded by Suydam, to approve the purchase of ten mattresses for the jail. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

Building Maintenance Supervisor Curt Malo joined the meeting with a request to repair the injector pump in the generator at the radio tower in the amount of \$3,500.00.

Moved by Cottingham, seconded by Lee, to authorize the repairs of the generator at the radio tower site. Discussion followed. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

The Chairperson recessed the meeting at 9:43 a.m.

Chairperson Cottingham reconvened the meeting at 9:50 a.m.

Recorder Heidi Anderson, Building Maintenance Supervisor Curt Malo, Tax Director/Veteran's Service Officer Todd Schreiner, Highway Superintendent Jim Grey, Disaster Emergency Manager Noelle Kroll, Chief Deputy Auditor Lori Foss, and NDSU Extension Agent Calandria Edwards were present for 2020 budget reviews.

Lee requested to close the courthouse at 3:00 p.m. on November 12, 2020 for the full-scale active shooter exercise.

Moved by Lee, seconded by Suydam, to approve closing the courthouse at 3:00 p.m. on November 12, 2020, for the full-scale active shooter exercise. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

The commission reviewed the departmental budgets for 2021 beginning with the Extension Agent budget making no recommendations for changes. Discussion followed regarding the Travel line item with Edwards stating that staff is OK with being paid mileage to use their personal vehicles.

Next, the commission reviewed the budgets for County Commission and Clerk of District Court eliminating \$4,677.15 and \$11,538.09 in the Overtime line item, respectively.

The commission reviewed the Juvenile Court budget for 2021 making no changes. Bailey stated that it is required to be included in the budget but hasn't been used in a long time.

The Auditor's budget was reviewed next with \$16,109.98 removed from the Overtime line item. Discussion followed regarding the \$20,000.00 in the Miscellaneous line item and additional office space.

Next, the commission reviewed the budget for State's Attorney reducing the Contingency Fund line item from \$3,750.00 to \$2,000.00.

The commission reviewed the Tax Director/Land Use budget for 2021 reducing the Overtime line item from \$12,596.81 to \$0.00. Lee requested the addition of line items to track gas and vehicle expense for the department for 2021.

The Veteran's Service Officer and Computer Operations budgets were reviewed next with the Overtime line item being reduced to \$0.00, resulting in \$1,942.85 and \$5,857.30 in reductions, respectively.

Next, the commission reviewed the Recorder's budget for 2021 with Lee reducing the Training/Conventions line item from \$2,800.00 to \$2,500.00. Recorder Heidi Anderson stated that the Salary line item will be lower due to the retirement of Deputy Recorder Pandy Hummel sometime next year.

Sheriff J. R. Kerzmann and Chief Deputy Sheriff/E-911 Coordinator Richard Johnson joined the meeting.

The Election Expenses and Non-Departmental Expenses showed no changes for 2021.

Malo presented a bill to fix an air handler in the Law Enforcement Center.

Moved by Lee, seconded by Suydam, to approve the air handler repairs not to exceed \$5,000.00. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

The commission reviewed the Building and Grounds budget reducing the Overtime line item to \$0.00. Discussion followed regarding building repairs needed with Lee stating that money needs to be spend to keep up the buildings or the county goes

backward. Lee asked if the current staffing was ok. Malo responded that he'd like to train someone on the equipment of the buildings and may ask for another full-time employee at some point.

Next, the commission reviewed the Sheriff's Department budget with Cottingham reducing the Overtime line item from \$173,413.22 to \$150,000.00. Also reduced was the SIRN Radio System line item from \$668,369.00 due to CARES Act funds received by the County. Kerzmann requested four new vehicles for 2021 due to seven current units running with over 130,000 miles on them.

Moved by Suydam, seconded by Lee, to transfer CARES Act funds in the amount of \$675,000.00 to cover the SIRN Radio System. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

The commission reviewed the Sheriff Vehicles budget for 2021 with no recommended changes.

Discussion followed regarding the Rescue Boat budget now that the boat and trailer have been gifted to the Garrison Fire Department. Suydam would like to see revenue going to the Garrison Fire Department if they have to respond to an incident outside their district with Kerzmann responding that other entities aren't subsidized due to Mutual Aid Contracts. Knutson recommended paying them the budgeted amount of \$4,500.00 with no vouchers for repairs or training coming in from them. Lee would like to see the amount reduced over time gradually divesting the county of any responsibility.

The Chairperson recessed the meeting at 11:19 a.m.

Chairperson Cottingham opened the public County Budget Hearing at 11:25 a.m.

Terry Sawicki of Wilton, Dwight Enockson of Washburn, Terry Thomsen of Baldwin, and Harley Halvorson of Turtle Lake were present.

Cottingham explained that roughly \$750,000.00 in budgets cuts have been made so far. Sawicki, Enockson, Thomsen, and Halvorson were present with questions regarding the taxation process. Lee stated that the published Preliminary Budget for 2021 showed a 5.51 mill increase with the commission looking for about a 3.5 mill reduction. The county hasn't had an increase for several years until the significant increase last year and Lee would like to see no increase this year. He explained that the State does the agricultural land assessing with ag land increases or decreases done by NDSU. Discussion followed.

Sawicki questioned the large increase for the McLean Mercer Regional Library. Suydam explained that they'd lost matching funds from the State and have to increase two mills in order to qualify for State Aid. Discussion followed regarding the book mobile, county park increases, the possible Coal Creek Station closure and wind towers.

Halvorson would like to see an end in sight to tax increases as they are getting hard to pay. Discussion followed.

Enockson questioned how the county is affected by oil. Knutson explained that it affects our revenues and was part of the reason for last year's increase. Enockson also questioned if the state depended too much on oil and is that trickling down to the county. Lee stated yes and so did the county. Fortunately, the State had reserves.

The Chairperson closed the budget hearing at 12:01 p.m. and immediately reconvened the commission meeting. Highway Superintendent Jim Grey and Disaster Emergency Manager Noelle Kroll rejoined the meeting.

The commission reviewed the Employee Benefits budget with no recommended changes. Discussion followed regarding the Salary Survey line item.

Next, the commission reviewed the Highway Administration budget reducing the Overtime budget line item to \$0.00 resulting in a reduction of \$9,303.68.

The Highway Equipment Expense budget saw possible cuts in the Capital Outlay line item from \$548,023.84 to \$313,000.00. Discussion followed with Knutson stating that Highway Revenues are short 1,800,000.00. Lee questioned where dollars come from for that shortfall to which Knutson responded the General Fund. She credited Grey with doing a good job watching for deals and sales for his purchases.

The Highway Shop – Washburn/Garrison and Highway Maintenance Sheds budgets were reviewed next with no changes needed.

Next, the commission reviewed the Highway Maintenance/Construction budget reducing the Gravel/Sand line item from \$500,000.00 to \$300,000.00 and the Bridge Materials line item from \$500,000.00 to \$250,000.00, while leaving the \$83,006.50 in the Overtime line item in case of a bad winter. Discussion followed.

The final Highway budget, Farm to Market, showed no changes. Discussion followed regarding possible future road projects.

The commission reviewed Disaster Emergency Manager/Risk Management Officer Noelle Kroll's budgets next showing no changes for her Employee Risk Management Program budget while the commission recommended cutting the Overtime line item of the Disaster Emergency Services budget from \$2,662.38 to \$1,300.00.

The Utilities, Dues/Membership, Motor Pool, Flexible Benefits-Medical & Child Care, and McLean County Park Board saw no recommended changes.

Next, the commission reviewed the McLean County Fair Board budget making no changes. Discussion followed with Cottingham requesting the Fair Board present a list of the improvements done this year due to no County Fair because of the Pandemic. Lee would like to see where they are at with their budget and what they have in the bank.

The Parole & Probation, Jobs Promotions, Senior Citizens, McLean County Historical Society, McLean County Coroner, Vehicle Impound & Towing, and School Resource Officer budgets were reviewed with no changes needed.

The commission reviewed the Weed Control budget reducing the Overtime line item to \$0.00 resulting in a reduction of \$8,000.00. Discussion following regarding sharing employees between the Highway Department and Weed Control as it's hard finding the summer help needed.

The Water Resource Board was reviewed next. Knutson will reach out to board member Lynn Oberg to see if there are areas that can be cut.

Next, the commission reviewed the Superintendent of Schools budget reducing the Overtime line item to \$0.00 resulting in a reduction of \$197.25.

Chief Deputy/E-911 Coordinator Richard Johnson rejoined the meeting for the review of his Communications and E-911 Coordinator budgets with the Communications budget showing no changes. The Equipment Purchase line item from \$100,000.00 to \$20,000.00; and the Overtime line item from \$1,378.32 to \$0.00. Johnson stated that there would be a monthly maintenance fee of \$2,000.00 for the new 911 system.

Knutson will put the final numbers together using today's recommended reductions in preparation for the Final Budget Hearing scheduled for October 6.

There being no further business, the chairperson declared the meeting adjourned at 1:00 p.m. until the next regularly scheduled meeting on Tuesday, October 6, 2020. The commission minutes and agenda can be found on the county website at http://www.mcleancountynd.gov.
