McLean County Commission Proceedings Tuesday, January 04, 2022

The first regular January meeting of the Board of Commissioners was called to order at 8:30 a.m. by Chairperson Steve Lee. Present were Commissioners Lee, Steve Cottingham, and Barry Suydam. Also present were Auditor Beth A. Knutson, Deputy Auditor Diane L. Blumhagen, Highway Superintendent Jim Grey, Director of Disaster Emergency Services/ Risk Manager Noelle Kroll, and Ralph Mancini of BHG News Service.

Moved by Suydam, seconded by Cottingham, to approve the minutes from December 7, 2021, as submitted. Roll Call Vote: Aye: Suydam, Cottingham, and Lee. Nay: None. Motion carried.

Grey was present with an update on department operations, informing the board that the Highway Department has hired Cole Seidler to under fill the open Equipment Operator III position as Equipment Operator II.

Kroll was present with the Risk Management accident statistics for 2021, showing seven accidents needing medical attention and 12 accidents not requiring medical attention.

Kroll requested approval to donate 15 used AED units that are not being utilized to local first responders and community groups. Discussion followed.

Knutson presented the commission with the Land Use Department's permit statistics for review.

Received and ordered filed the fee collection report from the Recorder's Office in the amount of \$10,585.80 for the month of December.

Received and ordered filed the fee collection report from the Sheriff's Office in the amount of \$783.56 for the month of December.

Knutson presented the budget narrative for period ending December 31, 2021. She presented data showing property tax collections are at 95% collected including 99% with discount for 2021 or \$18,616,831.82; Government Reimbursement revenues totaled \$2,609,629.95 compared to \$2,283,204.90 in 2020; Fees and Miscellaneous revenues totaled \$2,135,448.20 compared to \$4,206,368.99 in 2020; and expenditures were at 84.84% of total budget for 2021.

Knutson presented the Uncollected Tax List for years 2019-2021 showing the total amount of \$322,459.67.

Knutson presented the current list of delinquent tax payers owing more than \$4,000.00.
