McLean County Commission Proceedings Tuesday, January 19, 2016

The final regular January meeting of the Board of Commissioners was called to order at 8:32 a.m. by Chairperson Steve Lee. Present were Commissioners Lee, Barry Suydam and Doug Krebsbach. Also present were Auditor Les Korgel, Deputy Auditor Nancy Leidholm, Highway Superintendent Jim Grey, Risk Management Assistant/Disaster Emergency Services (DES) Manager Noelle Kroll, Wold Engineering representatives Ron Wagner and Mike Rivinius, and Alyssa Meier of BHG News Services.

Moved by Krebsbach, seconded by Suydam, to approve the minutes of the previous meeting as submitted. Roll Call Vote: Aye: Krebsbach, Suydam, and Lee. Nay: None. Motion carried.

Risk Management Assistant/DES Manager Noelle Kroll presented the statistics for the Risk Management program for the time period covering January 1, 2015 through December 31, 2015 showing 14 accidents requiring medical attention and 31 accidents not requiring medical attention, up considerably from 2014. Kroll went on to report that the County's Hazardous Mitigation Plan has been approved both by the state and by FEMA.

Moved by Suydam, seconded by Krebsbach, to adopt the McLean County Multi-Hazard Mitigation Plan as follows:

McLean County Multi-Hazard Mitigation Plan

Whereas, McLean County recognizes the threat that natural, man-made or technological hazards pose to people and property within our community; and

Whereas, undertaking hazard mitigation actions will reduce and/or eliminate the potential for harm to people and property from future hazard occurrences; and

Whereas, an adopted Multi-Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under multiple Federal Emergency Management Agency (FEMA) pre- and post-disaster mitigation grant programs; and

Whereas, McLean County participated in the preparation of this plan in accordance with the disaster Mitigation Act of 2000: and

Whereas, adoption of the McLean County Multi-Hazard Mitigation Plan demonstrates the commitment to hazard mitigation; and

Now, therefore, be it resolved, that the McLean County Commission adopts the McLean County Multi-Hazard Mitigation Plan.

Roll Call Vote: Aye: Krebsbach, Suydam, and Lee. Nay: None. Motion carried.

Kroll informed the commission that she had been contacted by the Red Cross regarding their Home Fire Preparedness Campaign whose aim is to make sure residents have adequate smoke detectors in their homes. She reported that the Riverdale Fire Department will conduct a campaign on February 2 in Riverdale.

Highway Superintendent Jim Grey reported that crews are out chasing snow around the county and cleaning up roads due to the recent snow fall. They continue to be busy in the shop doing maintenance on equipment for the upcoming year. He reported that the Equipment Operator II position in Garrison had been filled with Chris Magruder beginning February 1. Grey stated that the township meetings had gone well and reported that he will begin working on 2011 FEMA compliance reports. Grey questioned the commission regarding Capital Outlay spending wondering about the purchase of tires, fuel and cutting edges and was directed to make purchases as needed if he came across a good deal. He went on to report that he would be attending the ND Association of County Engineers Conference in Bismarck January 20 - 22. Grey informed the commission of an all-expense paid trip provided by Titan Machinery of Bismarck to Tomahawk, WI to tour the factory where the Case equipment is built, February 9 - 11.

Wold Engineering representatives Wagner and Rivinius submitted additions to House Bill (HB) 1176, specifically project CNOC-0028(022) as follows: (3 inch aggregate lift with subgrade repairs)

- County Road (CR) #6 from State Highway (SH) #41 east to CR #6S then south and east to CR #33 (10 miles) \$600,000,000
- CR #8 and CR #27 from SH #41 east to CR #27 junction then south to CR #27 asphalt (9 miles) \$600,000.00
- CR #27 from SH #200 north to SH #41 (2 miles) \$120,000.00
- CR #12 from CR #23 east to CR #12 asphalt (6 miles) \$360,000.00
- CR #25E from SH #200 north to CR #12 asphalt (4 miles) \$240,000.00
- CR #14 from CR #16 east to CR #15 (3 miles) \$180,000.00

Moved by Krebsbach, seconded by Suydam, to approve the 2016 project additions for House Bill (HB) 1176 CNOC-0028(022) for aggregate surfacing and subgrade repairs on approximately 34 miles of county roads as submitted. Roll Call Vote: Aye: Krebsbach, Suydam, and Lee. Nay: None. Motion carried.

Clerk of Court Cathy Bailey presented the commission with the 2015 Statistics Report for the Clerk of Courts office. She reported that the case load is down from 2014 because of traffic violation citations being written for municipal court rather than district court, which retains money for the cities instead of it going to the state. Bailey stated that 2015 had more felony cases than they've ever had before and that 2015 was a record year for restitution, collecting \$26,527.06 for victims of crimes.

Moved by Krebsbach, seconded by Suydam, to issue a raffle permit to Bis-Man Reel N Rec of Bismarck for a raffle to be conducted during a fishing tournament on Lake Audubon on February 20, 2016 with prizes being an ice house, ice auger, ice rod, ice rod case, fish finder, tip up, tackle box, gift cards, sled, heater, cooker, electric knife, rod and reel, ice chest, hat & gloves, ice scoop, rod & case, and fishing net, totaling \$1,525.00 in prizes. The raffle is to benefit the *Take a Kid Fishing* program. Roll Call Vote: Aye: Krebsbach, Suydam, and Lee. Nay: None. Motion carried.

Korgel presented his financial recap report for the period ending December 31, 2015 including the listing of delinquent tax payers in the county owing more than 4,000.00 which shows 6 property owners owing a total of 60,728.36; and the General Fund Income Comparison from 1985 - 2015. Property tax collections for 2015 stand at 98% compared to 99% on December 31, 2014. On the expense side we spent 84.91% of the 2015 budget.

Korgel reported that a new oil rig is going in the NW¼NW¼ of Section 6, Township 150 North, Range 91 West, located in the far northwest corner of the county.

Discussion followed regarding the possible borrowing of up to \$500,000.00 if it becomes necessary in the upcoming months; and the options of leasing or purchasing of equipment for the highway department was discussed as well.

Jim Grey rejoined the meeting for the scheduled 10:00 a.m. bid opening for motor grader lease/purchase along with Lowell Mallard of Butler Machinery of Bismarck, and Dustin Melby of RDO Equipment of Bismarck.

The first bid submitted was from RDO Equipment of Bismarck for a 2016 John Deere 772GP at \$314,000.00 which includes all options requested: slip clutch, ripper, lift group and snow wing. Trade in values and annual lease payments were listed as well.

The second bid submitted was from Butler Machinery of Bismarck for a 2016 Caterpillar 140M3 AWD at \$293,900.00 which includes the optional snow wing. Additional options requested would be at an additional cost to the county. Trade in values and annual lease payments were listed as well.

Grey will study the bids and return to the February 2, 2016 meeting with his recommendations.
