McLean County Commission Proceedings Tuesday, February 3, 2015

The first regular February meeting of the Board of Commissioners was called to order at 8:30 a.m. by Chairperson Barry Suydam. Present were Commissioners Suydam, Doug Krebsbach, and Steve Lee. Also present were Auditor Les Korgel, Chief Deputy Auditor Lori Foss, and Stu Merry of BHG News Service.

Moved by Krebsbach, seconded by Lee, to approve the minutes of the previous meeting as submitted. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Moved by Krebsbach, seconded by Lee, to amend the January 6, 2015 commission meeting minutes to read "Moved by Krebsbach, seconded by Lee, to reduce Curt Olson's salary to reflect his demotion from Captain to Patrol Deputy." instead of "Moved by Krebsbach, seconded by Lee, to reduce Curt Olson's salary to reflect his demotion from Captain to Patrol Deputy II." due to fact that there is no Patrol Deputy II classification. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Road Superintendent Jim Grey joined the meeting along with Ron Wagner of Wold Engineering. Grey reported that winter has treated us well up to this point so the department has had time to do some catch up work including tree trimming. He updated the board on a road project in the Deepwater area funded by the state. A department pickup truck in Garrison needs a transmission replacement at a cost of \$1,800.00. Lee questioned whether or not the unit was worth the investment to which Grey responded yes. The board then directed Grey to proceed with the repair using budgeted funds from the department's *Repair Parts* budget line item. Grey went on to discuss a department water pump that was originally obtained from US Fish and Wildlife; the unit needs an injection pump replaced at a cost of \$1,800.00. The board directed Grey to proceed with the repair as the unit could save us money by eliminating the need to rent a pump if the need arises in the spring. Grey requested permission to secure bids for the budgeted excavator and loader purchase.

Moved by Lee, seconded by Krebsbach, to authorize Grey to secure bids for the purchase of an excavator and loader. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Grey requested and received permission to attend a Customer Appreciation event hosted by Titan Machinery on February 10-12, 2015 in Wisconsin. The event will include product demonstrations as well as hands on experience with new equipment models. The cost of the event and related travel expenses will be paid by Titan Machinery.

Moved by Lee, seconded by Krebsbach, to approve the utility permit request from Reservation Telephone of Parshall to bore under McLean County Road (CR) #1 at a distance of 80 feet north of the junction of CR #1 and North Dakota State Highway #1804 to install and maintain fiber optic cable to provide service to Florence Dubray. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Krebsbach questioned Korgel regarding whether or not a process exists or can be established for reimbursement of fuel costs from the Park Board, Weed Control and County Motor Pool to the Highway Department. Currently those departments obtain fuel from pumps located at Highway Department Shops in Garrison and Washburn with the costs covered entirely by the Highway Department. Korgel said that there was not a process in place but that he felt he could come up with something. The Commission then directed Korgel to establish a system for payback from other county departments to the Highway Department for accurate accounting of fuel costs by department.

Wagner presented a request from Wold Engineering on behalf of Mike Rivinius who was unable to attend today's meeting. The request was for approval of plans and the setting of a bid letting date for a 9 mile microseal surfacing project on CR #8.

Moved by Lee, seconded by Krebsbach, to approve the plans and set 10:00 a.m. on March 17, 2015 as the bid letting for the microseal surfacing project on CR #8 formally known as Project CP-2814(015). Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Wagner went on to discuss three culvert projects planned for the county stating that it's possible a bid letting could be held on the same date.

Land Use Administrator Todd Schreiner and his assistant Cassandra Goetz joined the meeting with one item requiring final zoning action from the regular Planning & Zoning Commission meeting held on January 20, 2015.

Moved by Krebsbach, seconded by Lee, to concur with the Planning & Zoning Commission and approve the request for a conditional use permit for Darren and Ruth McLachlan of Washburn involving land described as Outlot A in Government Lot 2 of Section 4, Township 144 North, Range 82 West, to construct a non-farm structure on agricultural land. Roll Call Vote: Aye: Lee, Suydam and Krebsbach. Nay: None. Motion carried.

Schreiner informed the board that there will be no Planning and Zoning Commission meeting in February due to lack of timely requests.

The board received and ordered filed the monthly revenue report submitted by the Sheriff's office in the amount of \$1,013.34 for the months of December and January.

The board received and ordered filed the monthly revenue report submitted by the Recorder's office in the amount of \$6,533.10 for the month of January.

Korgel presented a financial recap for the period ending January 31, 2015 including a listing of delinquent taxpayers owing more than \$4,000.00 which shows 7 taxpayers owing a total of \$81,600.43. Property tax collections overall stand at 53% compared to 57% on January 31, 2014. On the expense side we have spent 7.60% of the 2015 budget.

Korgel informed the board that Noelle Kroll assumed the appointed position of Disaster Emergency Services (DES) Manager on February 1, 2015. He requested that the board reimburse Kroll for use of her personal cellular phone service at the established rate of \$30.00 per month.

Moved by Krebsbach, seconded by Lee, to reimburse DES Manager Noelle Kroll \$30.00 per month for use of her personal cellular phone service for county business. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

The board conducted first readings of proposed changes to *Personnel Manual Policy 303 – Annual Leave* and *Personnel Policy 406 – Overtime and/or Compensatory Time*. The annual leave policy was changed to require all employees to use 75% of their accumulated annual leave by October 1 of each year. The compensatory time policy was changed to require employees to use accumulated compensatory time prior to any other paid leave (sick or annual) if that employee has compensatory time available. The compensatory time was also reworded to strongly encourage employees to use any accumulated compensatory by the end of month following the month that the time is earned.

Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Sheriff J.R. Kerzmann, Chief Deputy Sheriff Richard Johnson, and Jail Administrator Wade Krohmer joined the meeting. Johnson presented a job description for newly created Jailer/Dispatcher/Emergency Medical Dispatch Sergeant position. The job description was reviewed by Chief Deputy Auditor Lori Foss prior to today and found to be adequate.

Moved by Krebsbach, seconded by Lee, to approve the job description for the Jailer/Dispatcher/Emergency Medical Dispatch Sergeant position as submitted by Chief Deputy Sheriff Richard Johnson. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Johnson presented a job description for another newly created position of Lieutenant/Training Supervisor. The board again questioned Foss as to whether or not she had a chance to review it prior to today's meeting to which she responded yes and that everything was in order.

Moved by Krebsbach, seconded by Lee, to approve the job description for the Lieutenant/Training Supervisor position as submitted by Chief Deputy Sheriff Richard Johnson. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Kerzmann informed the board that a current Jailer-Dispatcher resigned this morning without two weeks' notice because of disappointment in not receiving a promotion to Jailer/Dispatcher/Emergency Medical Dispatch Sergeant. The resignation is effective immediately. The board directed Kerzmann to fill the vacancy at this Friday's interviews if possible hiring three from the pool rather than the advertised two or more.

The board directed the Sheriff's Department to communicate to Foss the names of the individuals who will receive promotions to the newly created positions of Jailer/Dispatcher/Emergency Medical Dispatch Sergeant and Lieutenant/Training Supervisor along with the promotion of J.D. Young Bird to Patrol Sergeant.

Korgel presented an issue regarding Young Bird's annual leave balance as a returning employee. It is the policy of the county to allow any employee who leaves county employment and returns within one year to maintain their leave balances at the level that they left at on their termination date. Young Bird did not return within the one year time period; he returned two years after terminating. Discussion followed stating that there was some confusion as to what was promised to Young Bird at his interview regarding annual leave and it was mentioned that during his prior employment he was an exemplary employee.

Moved by Lee, seconded by Krebsbach, to restore Young Bird's annual leave to the level that he left at in 2012 which was 192 hours per year. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Discussion followed on the probable promotion of newly hired Sheriff's Department employee Ricky L. Richard to the position of Lieutenant/Training Supervisor regarding the establishment of an annual salary.

Moved by Lee, seconded by Krebsbach, to set Ricky L. Richard's starting salary at \$59,894.00 in acknowledgement of his years of experience with the North Dakota Highway Patrol pending official notification of his promotion to the position of Lieutenant/Training Supervisor noting that there would be no further salary adjustments after six months since his probationary period was waived at the last commission meeting. Roll Call Vote: Aye: Suydam, Lee, and Krebsbach. Nay: None. Motion carried.

Discussion followed regarding the bill in the legislature that would mandate five commissioners in each county.

There being no further business, the chairperson declared the meeting adjourned until the next regularly scheduled meeting on Tuesday, February 17, 2015. The commission minutes and agenda can be found on the county website at http://www.visitmcleancounty.com/officials/meetings.html.
