McLean County Commission Proceedings Tuesday, April 19, 2016

The final regular April meeting of the Board of Commissioners was called to order at 8:30 a.m. by Vice-Chairperson Doug Krebsbach. Present were Commissioners Krebsbach and Barry Suydam. Absent was Commissioner Steve Lee. Also present were Auditor Les Korgel, Deputy Auditor Nancy Leidholm, Mike Matteson, Glenn Schreiner and Nick Schreiner of Garrison, Riverdale Council Member Ken Skuza, Riverdale City Auditor Del Kolke, States Attorney Ladd Erickson, County Assessor Ryan Oberg, Land Use Assistant Cassie Goetz, and Director of Emergency Services (DES) Manager Noelle Kroll.

Moved by Suydam, seconded by Krebsbach, to approve the minutes of the previous meeting as submitted. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Highway Superintendent Jim Grey joined the meeting with a department update. He reported that County Road (CR) #37 into Roseglen is in bad shape and is considering turning it back into a gravel road in the future as this option is cheaper than an overlay. Grey told the Commission that shoulder work is being done. Suydam informed Grey that he'd received a compliment from a county citizen praising Highway Department employee Keith Ellison on the good job he's doing on CR #5. Grey discussed the broken spray bar on his distributor truck and requested advertising for bids to see what they could get for it. Korgel suggested getting some costs for repairing the spray bar on the truck as well as the cost for a spray bar for a trailer. Krebsbach agreed.

Ron Wagner of Wold Engineering joined the meeting with construction agreements for approval.

Moved by Suydam, seconded by Krebsbach, to approve the Construction Agreement with Aggregate Construction, Inc. for Project CNOC-0028(022), a county road graveling project. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Moved by Suydam, seconded by Krebsbach, to approve the Construction Agreement with Mayo Construction, Inc. for Project CP-2879(016), a micro surfacing and seal coat project. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Moved by Suydam, seconded by Krebsbach, to approve the North Dakota Department of Transportation Construction Services Agreement for Federal Aid Project BRO-0028(021), a triple box culvert with Wold Engineering. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

County Assessor Ryan Oberg and Land Use Assistant Cassie Goetz joined the meeting to present recommendations from yesterday's Planning & Zoning Commission meeting.

Moved by Suydam, seconded by Krebsbach, to concur with the Planning & Zoning Commission and approve the request from Shannon Torgerson of Max and Jeff Martinson, representing Pinky's Aggregate, Inc. of New Town, to operate a sand and gravel pit for mining, processing and selling of sand and gravel products for land described as the E½SE¼ of Section 26, Township 150 North, Range 82 West, involving 30 acres. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Moved by Suydam, seconded by Krebsbach, to concur with the Planning & Zoning Commission and approve the request from Glenn Schreiner of Garrison for a rural subdivision plat for land described as the 5%SE% of Section 24, Township 148 North, Range 84 West, to be known as Lots 1-7, Block 1 and Lots 1-8, Block 2, Schreiner Centennial Addition. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Moved by Suydam, seconded by Krebsbach, to concur with the Planning & Zoning Commission and approve the conditional use permit request from Delmar Rodgers for land described as the SW%SW% of Section 22, Township 145 North, Range 80 West, known as Outlot A, including 7.19 acres, to construct a non-farm structure on agricultural land. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Sheriff J. R. Kerzmann, Chief Deputy Sheriff/E-911 Coordinator Richard Johnson, and Assistant Jail Administrator Wade Krohmer joined the meeting.

States Attorney Ladd Erickson, County Assessor Ryan Oberg, Riverdale City Auditor Del Kolke, and Riverdale City Council Member Ken Skuza were present to discuss discontinuing the assessing contract between the County and City of Riverdale due to Riverdale's assessing needs possibly exceeding the county's offered level of service. Erickson feels there needs to be a uniformity throughout the county so that all properties are taxed at the same percentage of value and asked the Commission to address the issue. Oberg, Kolke and Skuza agreed that there is a lack of communication between Riverdale residents and the County. Krebsbach directed Oberg to put together a written policy of what the county will offer for assessing. Discussion followed. The Commission made no recommendations due to Commissioner Steve Lee's absence.

DES Manager Noelle Kroll and Chief Deputy Sheriff/E-911 Coordinator Richard Johnson were present. Kroll informed the Commission of the final approval from the State and FEMA regarding the County's Hazardous Mitigation Plan.

Kroll and Johnson requested permission to purchase three radios for the Sheriff's Department utilizing DES Grant funds of \$11,043.00, paying the remainder out of the E-911 Equipment Purchases account as radios were budgeted for this year.

Moved by Suydam, seconded by Krebsbach, to approve the purchase of three Motorola APX3500 VHF mobile radios for the Sheriff's Department in the amount of \$12,154.50, utilizing funds from the FY 2014 Supplemental State Homeland Security Grant Program of \$11,043.00; the remaining amount of \$1,111.50 to come out of the E-911 Equipment Purchases account.

Assistant Jail Administrator Wade Krohmer requested permission to purchase a new commercial gas range for the Law Enforcement Center and presented a quote from Capital City Restaurant Supply, Bismarck, in the amount of \$2,010.00. The existing stove is getting old, burners are going out, and it is expensive to get someone here from Bismarck when repairs are needed. There

would also be an additional cost for MDU to tap into the existing gas line. This purchase was cut from the 2016 budget, but Korgel feels we can make it work, though he is concerned about having a gas stove in a kitchen with prisoners helping out.

Moved by Suydam, seconded by Krebsbach, to approve the purchase of the commercial gas range from Capital City Restaurant Supply, Bismarck, in the amount of \$2,010.00 and the additional expense to have MDU tap into the existing gas line. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Krohmer reported that he terminated Jailer/Dispatcher Kimberly Janz and has demoted Jailer/Dispatcher Sergeant Jeff Turning Heart Jr. to Jailer/Dispatcher.

Korgel presented the 2017 Police Contracts with the cities recommending no changes from the 2016 contracts.

Moved by Suydam, seconded by Krebsbach, to approve the 2017 Police Contracts as submitted. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Moved by Suydam, seconded by Krebsbach, to approve the Gaming Site Authorization for the American Foundation for Wildlife to conduct bingo and pull tabs at Totten Trail Resort from July 1, 2016 through June 30, 2017. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Moved by Suydam, seconded by Krebsbach, to approve the raffle permit request from the McLean County Racer's Association for a raffle to be held on August 4, 2016 with a total prize value set at \$4,338.19 with raffle proceeds directed to McLean County Racetrack expenses. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried..

Moved by Suydam, seconded by Krebsbach, to approve the Special Event Permit Application from Hometown Tavern for a wedding dance on June 25, 2016 at Hiddenwood Lake. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Korgel presented an updated job description for the Disaster Emergency Services Director position, reclassifying the position from exempt to non-exempt due to the fact that the position that Kroll spends the majority of her time in is non-exempt and according to the North Dakota Department of Labor one employee holding two positions cannot be classified as both exempt and non-exempt.

Moved by Suydam, seconded by Krebsbach, to approve the job description for Disaster Emergency Services Director as submitted. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Moved by Suydam, seconded by Krebsbach, to approve the salary adjustment from \$47,018.83 to \$49,625.00 for Sheriff's Department employee Justin Cote, retroactive to March 1, 2016, due to his promotion from Patrol Deputy to Patrol Deputy Senior Officer. Roll Call Vote: Aye: Krebsbach and Suydam. Nay: None. Absent and not voting: Lee. Motion carried.

Discussion took place regarding barrels of oil produced within the county.
