

**McLean County Commission Proceedings**  
**Tuesday, June 21, 2016**

The final regular June meeting of the Board of Commissioners was called to order at 8:32 a.m. by Chairperson Steve Lee. Present were Commissioners Lee and Doug Krebsbach. Also present were Duane Hummel of Northern Plains Equipment Company of Garrison, Auditor Les Korgel, Deputy Auditor Nancy Leidholm, and Suzanne Werre of BHG News Services. Absent was Commissioner Barry Suydam.

Moved by Krebsbach, seconded by Lee, to approve the minutes as submitted for the previous meeting as well as for the Board of Equalization meeting. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Highway Superintendent Jim Grey along with Wold Engineering representative Mike Rivinius joined the meeting. Grey reported that magnesium chloride would be applied on roads in the Wolf Creek area as well as County Road (CR) 13 and on Township Road 30. He stated that gravelling and riprap continues around the county and crews were working on cleaning bridge tops of excessive gravel. Grey reported that the aggregate lift on CR 6 had been completed with work to begin on CR 8 today. Chip sealing on CR 33 began last Thursday.

Rivinius reported that the plans for repairs on a bridge south of Washburn are close to being finished and should go to bid soon. He and Korgel informed the Commission of changes regarding state inspection of new bridges.

Discussion followed about an issue at Wolf Creek regarding dust control on the roads. Grey stated that the process is beginning this morning. Lee feels the Sheriff's Department should be contacted. Grey will keep an eye on things.

Grey recommended accepting the bid from Northern Plains Equipment Company of Garrison for a 2015 Case IH Maxxum in the amount of \$77,995.00. Krebsbach questioned what the checkbook looks like and Korgel responded that we can cover that.

Moved by Krebsbach, seconded by Lee, to concur with Grey and award the tractor bid to Northern Plains Equipment Company of Garrison for a 2015 Case IH Maxxum in the amount of \$77,995.00. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Discussion took place regarding rental tractors.

Korgel presented the Police Contract for the City of Butte for signing.

Land Use Assistant Cassie Goetz joined the meeting with recommendations from the Planning & Zoning Commission.

Moved by Krebsbach, seconded by Lee, to concur with the Planning & Zoning Commission and approve the request from Travis Grosche for a variance of the setback requirements of the McLean County Zoning Ordinance for land described as Lot 17, Block 2, Severance Resort, located in Township 150 North, Range 80 West, Otis Township, to allow the construction of a structure closer than the required 15 foot setback from the side lot line. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Moved by Krebsbach, seconded by Lee, to concur with the Planning & Zoning Commission and approve the request from Harry W. Mowbray for a conditional use permit for land described as the NE¼NE¼NE¼ of Section 25, Township 150 North, Range 78 West, known as Outlot A, to construct a non-farm structure on agricultural land, pending a call to First District Health regarding a septic system. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Moved by Krebsbach, seconded by Lee, to concur with the Planning & Zoning Commission and approve the request from Sundre Sand & Gravel, Inc. for a conditional use permit for land described as the N½NE¼ of Section 21, Township 149 North, Range 80 West, 70 acres proposed, to operate a sand and gravel pit for mining, processing and selling of sand and gravel products. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Moved by Krebsbach, seconded by Lee, to concur with the Planning & Zoning Commission and approve the request from Sundre Sand & Gravel, Inc. for a conditional use permit for land described as the NW¼NE¼ of Section 1, Township 146 North, Range 81 West, and the SW¼SE¼ of Section 36, Township 147 North, Range 81 West, 20 acres proposed, to operate a sand and gravel pit for mining, processing and selling of sand and gravel products. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Korgel presented the 2016 Primary Election review.

Moved by Krebsbach, seconded by Lee, to appoint Dakota Central Social Services Director Steve Reiser to serve as McLean County's delegate to the National Association of Counties convention. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Sheriff J. R. Kerzmann and Chief Deputy Sheriff Richard Johnson joined the meeting.

Johnson noted that he has a Jailer/Dispatcher Assistant who is not working because of illness. He said employees have asked to be allowed to give sick days to the employee that is out of sick leave time.

Moved by Krebsbach, seconded by Lee, to allow sheriff's employees to donate 24 hours of sick leave for June and up to 152 hours for July, to an employee without sick leave days, in accordance with county policy. Roll Call Vote: Aye: Krebsbach and Lee. Nay: None. Absent and not voting: Suydam. Motion carried.

Kerzmann requested and was granted permission to use Drug Forfeiture Funds for the purchase of ammunition for Advanced Shooter School for Patrol/Contract Deputy Paul Barrette.

Kerzmann and Johnson presented the comp hours for the Sheriff's Department. Korgel recommended paying those individuals with balances over 80 hours; those individuals would be paid the number of hours that they have over the 80 hour maximum.

Kerzmann told the Commission that in working on the 2017 budget, he is looking at the possibility of purchasing 4-door Dodge pickups with police packages. They are less expensive than the Ford Expeditions that the department now uses. Lee has no objection and stated that a pickup has better resale. Korgel added that they could be rotated to the County Park, Highway Department or Weed Control when no longer suited for the Sheriff's Department.

Kerzmann informed the Commission of \$8,600.00 damage to his vehicle. Discussion followed.

Discussion followed regarding Law Enforcement Center prisoner population. Kerzmann stated that the daily average is about 30; 11 being county prisoners and the rest on contract.
