SPORTSMEN'S CENTENNIAL PARK RULES Please read these rules carefully!

This is a summary of rules which apply to all users of Sportsmen's Centennial Park. The McLean County Park Board is able to maintain this area only if you follow the rules. The park is patrolled daily by McLean County Sheriff's officers and park employees.

1. <u>A PAID PERMIT IS REQUIRED FOR ALL OVERNIGHT CAMPING</u>. The fee is \$15.00 per night for nonelectrical sites and \$25.00 per night for electrical hook-up sites. Additional units may be on the same site by paying the daily rate. Electrical sites are limited to ONE unit. Daily occupancy is required and guest may camp 30 days during any 60 consecutive day period.

1b. PERMITS MUST BE DISPLAYED ON SITE. Conduct a drive-through of the park to determine which site you want. RESERVED SITES will be tagged. If there is no tag, the site is open for that day. Once you have selected OPEN site IMMEDIATELY reserve the site online an at https://app.fireflyreservations.com/Reserve/Property/SportsmensCentennialPark . The park manager will be notified of your reservation. Check out time is 4 p.m. Early check-in is permitted if the site is available. All campers, including tents, must secure daily permits which will include vehicle owner's name, vehicle ID and license number for reference in event of any rules violations and to locate campers in the event of emergency. Camping will be allowed in designated areas only. Shoreline camping IS NOT ALLOWED. Day use parking for fishermen is allowed in designated boat ramp areas only.

Sites with **<u>RED</u>** numbered markers are for long term camping.

1c. The Park does accept advance reservations and some sites may be reserved. They will be marked with <u>RESERVED</u> signs on the site marker and are not available for occupancy. <u>Persons parking in reserved</u> <u>areas WILL be forced to relocate to another site</u>. All campers coming on a site available basis must pay immediately after selecting a camp site. All reserved sites should be posted but <u>campers without</u> <u>reservations MUST check with park personnel or reserve online before setting up at a vacant site</u>. This is to insure that they are not in a reserved area, should the reserved sign be missing. All long time sites will have <u>RED</u> site markers.

1d. <u>CAMPSITE PERMITS ALLOW FOR PARKING OF A CAMPING UNIT</u>. Campers may park a boat/trailer at site if space permits. Additional vehicles and boat/trailers **MUST** be parked in overflow parking areas. **PARKING IS NOT ALLOWED ON ANY PARK ROADWAYS OR ROAD EDGE DUE TO NARROW ROADS THROUGHOUT THE PARK.**

2. <u>ALL PETS MUST BE ON A PHYSICAL LEASH AT ALL TIMES. PETS RUNNING AT-LARGE WILL BE</u> <u>IMPOUNDED</u>...PLEASE CLEAN UP AFTER YOUR PET.

3. <u>CUTTING OF FIREWOOD IS PROHIBITED</u>. <u>WOOD PALLETS ARE NOT ALLOWED AS FIREWOOD</u>. Firewood is for sale at Centennial Store. Trash burning is not allowed.

4. <u>CONSTRUCTION OF FIRE RINGS IS PROHIBITED</u>. All campfires shall be confined in metal fire boxes and metal fire rings. <u>NOT ALL CAMPSITES HAVE CAMPFIRE FACILITIES</u>. **DO NOT move fire rings at any time.**

5. Picnic tables <u>SHALL NOT</u> be moved from one campsite to another site. <u>Not all campsites have</u> <u>picnic tables</u>.

6. Digging or otherwise disturbing soil within park is prohibited. This includes leveling for camping units and burying any type of garbage.

7. ATV's, OHV's and golf carts are now banned. **Park Employees and Sheriff Deputies will enforce this rule.** Shoreline motorized vehicle use of any kind is <u>PROHIBITED</u>. This includes use of mopeds, all-terrain vehicles, and motorized scooters. Any motorized toys such as jeeps, hover boards, motorbikes, etc...are also not allowed. The use of drones on public land is prohibited.

8. Discharge of <u>FIREARMS AND FIREWORKS</u> within park area is <u>PROHIBITED</u> at all times. Federal regulations PROHIBIT either of the above. Violations will result in issuance of citations and fines and/or loss of camping privileges without refund. NO GUNS IN PARK EXCEPT FOR PURPOSE OF HUNTING DURING HUNTING SEASON. CONCEALED WEAPONS ARE NOT ALLOWED.

9. 10:00 PM to 7:00 AM is considered "<u>QUIET</u>" hours in the park. OPERATION OF ELECTRIC GENERATORS IS PROHIBITED DURING THESE HOURS! CHECK WITH PARK OFFICE FOR ANY AMENDMENTS.

10. <u>Copies of these rules are available at registration and in the **BOX** in front of the office</u>. Failure to be aware of the rules will not be accepted if issuance of a citation is considered.

11. USERS WILL BE HELD LIABLE FOR ANY DAMAGES TO PARK FACILITIES.

12. Showers are for the use of paying campers ONLY!

13. Federal regulations prohibit medical and recreational marijuana on Federal Lands.

14. A dump station is available for camper use at the Garrison city shop, located at 149 4th St SW, Garrison, ND.

15. First District Health requires campers to keep a 10-foot spacing from adjacent campers.
