McLean County Commission Proceedings Tuesday, January 23, 2024

The second regular January meeting of the Board of Commissioners was called to order at 8:31 a.m. by Chairperson Steve Cottingham. Present were Commissioners Cottingham, Steve Lee, and Barry Suydam.
