McLean County Commission Proceedings Tuesday, April 2, 2024

The first regular April meeting of the Board of Commissioners was called to order at 8:40 a.m. by Chairperson Steve Cottingham. Present were Commissioners Cottingham, Steve Lee, and Barry Suydam. Also present were Auditor Beth A. Knutson; Deputy Auditor Diane L. Blumhagen; and Dan Johannes.

Moved by Lee, seconded by Suydam, to approve the Executive Session minutes held on March 19, 2024. Roll Call Vote: Aye: Lee, Suydam, and Cottingham. Nay: None. Motion carried.

Johannes addressed the commission regarding the status of the gravel out by his place. Discussion followed.

Building and Maintenance Supervisor Curt Malo joined the meeting to present a proposal from Electric System Inc. for the amount of \$1,940.00 to remove desk from the Recorder's Office which contains electricity and data.

Moved by Lee, seconded by Suydam, to approve the proposal from Electric Systems Inc. as presented. Discussion followed with Knutson stating the funds will be taken out of Building Maintenance budget line item. Roll Call Vote: Aye: Suydam, Lee, and Cottingham. Nay: None. Motion carried.

Cottingham tabled the Road Policy for an upcoming meeting.

Knutson presented an update on the Vision West meeting. Discussion followed.

Knutson presented the budget narrative for period ending March 31, 2024. She presented data showing property tax collections are at 89% collected including 93% with discount for 2024 or \$19,396,012.06; government reimbursement revenues totaled \$674,661.46 compared to \$543,955.59 in 2023; fees and miscellaneous revenues totaled \$354,493.07 compared to \$401,035.36 in 2023; and expenditures were at 23.91% of total budget for 2024.

 $Knuts on \ presented \ the \ current \ list \ of \ delinquent \ tax \ payers \ owing \ more \ than \ \$4,000.00 \ showing \ 74 \ tax payers \ owing \ \$682,081.69 \ in \ back \ taxes.$

Knutson presented the Uncollected Tax List for years 2021-2023 showing a total of \$1,937,306.56.

Knutson informed the board that she received of a letter from North Dakota Public Human Services stating the updated Indirect Cost Plan was approved. Discussion followed.

Commissioner Lee discussed the previously approved salary survey from North Dakota Association of Counties (NDACo) and requested a letter from the county be sent to NDACo salary requesting not to exceed \$500.00. Discussion followed.
