Perry Hesch and Brandon Lerbakken representing JMAC Resources, Inc. of Bismarck, ND were present to request approval of a conditional use permit for land located in the NE¼ of Section 26, Township 144 North, Range 81 West, containing 35-39 acres, for gravel pit operations including mining, processing, and selling of sand and gravel products. The land is owned by Dan & Sandra Wicklander of Washburn. Schreiner explained that once the \$50,000.00 performance bond is in place the permit can be issued.
